## STRICT COMPLIANCE REQUIREMENTS

Each medical device is regulated by laws that are often revised by governing bodies across various countries. In addition, each device is uniquely configured based on specific compliance rules, such as calibration thresholds. The company needed a solution that could be scaled across multiple jurisdictions while meeting the strict regulatory requirements of each country.
